AMENDMENTS TO ARTICLES OF INCORPORATION

BE IT KNOWN BY THESE PRESENTS that the undersigned President and Secretary of the above named Corporation not for profit, formed under the laws of the State of Florida pursuant to Florida Statute 617, et seq, hereby certify as follows:

- 1. At the annual joint meeting of the Board of Directors and general membership of the above named Corporation on October 30, 1980, that all members of the Board of Directors were present and more than seventy five percent (75%) of the membership entitled to vote on amendments to the Articles of Incorporation were present.
- 2. That at said meeting, upon the unanimous approval and recommendation of the Board of Directors, the following resolutions amending these Articles of Incorporation were adopted by an affirmative vote of more than seventy five percent (75%) of the members of the entire Association, to wit:

BE IT RESOLVED THAT Articles IX and X of the Articles of Incorporation of this Corporation (referring to amendment procedure to these Articles of Incorporation) be, and hereby are, amended to read as follows:

ARTICLE IX

BY-LAWS

The original by-laws are to be made by the Board of Directors and are declared under such declaration. The same may be amended thereafter only by approval of sixty percent (60%) of all of the Directors and not less than sixty percent (60%) of the members of the Association.

ARTICLE X

AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended only with the approval of sixty percent (60%) of all the Directors and not less than sixty percent (60%) of the members of the Association.

BE IT FURTHER RESOLVED THAT Article VIII of the bylaws of the Corporation, sub-paragraph (b), which concerns amendment procedure, is hereby amended to read as follows:

(b) A Resolution adopting a proposed amendment must receive approval of sixty percent (60%) of the votes of the entire membership of the Board of Directors, and sixty percent (60%) of the votes of the entire membership of the Corporation. Directors and members not present at the meetings considering the amendment may express their approval in writing.
